

University of Glasgow BDS Undergraduate Dental programme

1. The University of Glasgow (UoG) has agreed to make available for the 2019 intake 3 seats in the BDS Undergraduate Dental Programme to qualified candidates who meet the entry requirements.
2. Upon successful completion of the five years of the medical programme at the University of Glasgow, it is University of Glasgow's expectation that graduates will not be eligible for, and will not apply, for Foundation Year 1/Year 2 (FY1/FY2) programme, for provisional and/or full registration with the General Medical Council in the United Kingdom.
3. Upon successful completion of the five years of the dental programme at the University of Glasgow, graduates will be eligible to apply for full registration with the General Dental Council, however, the University is not responsible for, nor in a position to offer, entry to the Scottish Dental workforce.

Entry requirements

Applicants should be Mauritian citizens and hold the following qualifications -

(i) English Language

All applicants must meet the following English language requirement.

An IELTS score of 7.0 with no sub test less than 7.0 or IBTOFEL of 100 with no sub test less than 24 (or alternative as detailed on the UoG website).

For Degree of Bachelor of Dental Surgery

(ii) A Level – AAA including Biology and Chemistry (Both at grade A). (General Studies is not acceptable as a third subject.) or IB – 36 points including Chemistry HL 6 and Biology HL 6, and either Mathematics or Physics at HL or SL6

(iii) Students will have to undergo a competitive selection interview, health and police check.

The University of Glasgow shall have absolute discretion as to whether an applicant has met the Entry Requirements and should be offered a place on a Programme.

Fees

The annual tuition fee will be fixed for the duration of the programme at the fee level set on entry. For BDS students the fee will be forty-two thousand, one hundred and seventy pounds sterling (£42,170) per year for each year of the five (5) year programme.

Important Note

(a) Applicants should

i. comply with UK Immigration and visa requirements.

ii. be aware that securing the offer of a place on a Programme does not guarantee entry to the UK to study and that it shall be the applicant's responsibility to obtain the necessary visa and/ or permits to study in the UK;

iii. be aware that obtaining a visa to study on a programme does not entitle graduates from a Programme to enter into the UK workforce.

(b) A self-financing student who is not the beneficiary of a scholarship awarded by the Government of Mauritius has the responsibility to make payment of the fees to University of Glasgow failing which the student will not be able to graduate from the relevant award from University of Glasgow.

(c) A student who is a beneficiary of a scholarship awarded by the Government of Mauritius will be responsible for any outstanding amount, exceeding the amount covered by the Scholarship, owed to University of Glasgow failing which the student will not be able to graduate from the relevant Programme and receive the relevant award from University of Glasgow.
